

COLONEL BRETT A. LANDRY

Colonel Brett Landry is the Deputy Lead Special Trial Counsel, Office of the Special Trial Counsel, Department of the Air Force, Washington, DC. In that job, Colonel Landry assists the Lead Special Trial Counsel with oversight of the Department's legal representation in the investigation and trial-level litigation of covered offenses pursuant to 10 U.S.C. § 801(17) of the Uniform Code of Military Justice and other offenses over which the office exercises authority. The Department's Office of Special Trial Counsel operates independently of the military chains of command of those accused of covered offenses. The Office of the Special Trial Counsel reports directly to the Secretary of the Air Force with no intervening authority.



Colonel Landry was born in Belle Chasse, LA. Prior to joining the Air Force, he earned an undergraduate degree in Business Administration from Louisiana State University. He went on to attend law school at LSU, earning his JD in 2004. During law school,

Colonel Landry clerked for two years with the United States Attorney's Office, Middle District of Louisiana. He was admitted to the Louisiana Bar in October of 2004 and was commissioned by direct appointment that same month. Col Landry attended Officer Training School in November 2004. Colonel Landry and his wife, Natasha, have twin daughters, Julianne and Alexandra.
