

# UNITED STATES AIR FORCE SPECIAL VICTIMS' COUNSEL PROGRAM



The Special Victims' Counsel (SVC) Program delivers victim-centered advice and advocacy through comprehensive, independent representation to sexual assault victims worldwide, assists them in obtaining support and recovery resources, and promotes greater confidence in the military justice process and the United States Air Force.

SVCs advocate and succeed in shaping the military justice landscape by ensuring that each victim is treated with dignity and respect beginning with the investigation, continuing through the court-martial process, and remaining involved during the post-trial process by filing briefs in the Service Courts and the Court of Appeals of the Armed Forces.

**“[My SVC] fought for me fiercely... He provided me with all of my options (as far as writ of mandamus and appeals go), then allowed me to make my own decision.”**



- 99% of the victims surveyed would recommend other victims request an SVC.
- 86% of the victims surveyed indicated they were “extremely satisfied” with their SVC’s representation.
- 69% of the victims represented by the SVC Program were referred by the SAPR Office.
- 58% of all children represented by the SVC Program were referred by Family Advocacy.
- 20% of the represented victims over the life of the program have been civilian dependents, DoD civilians, or civilians not affiliated with the military.



**“Of all the programs that exist with regards to sexual assault in the military, the SVC program is by far the most important one... Without my SVC, I would have felt I was drowning and powerless to have my voice heard.”**
